**Footnotes:**

- (1) All Sierra County TRAs are within the Sierra Plumas Joint Unified School District which includes all elementary and high schools. Part of the SPJUSD is in Plumas County. The SPJUSD has no bonded debt.
- (2) Solid Waste Fee was changed beginning with the 2011-12 unsecured roll and is calculated as follows: \$13.59/loose cubic yard: Example: 1 residence = 17 LCY x 13.59 = \$231.03.
- (3) Sierra County Waterworks Dist. 1 (Calpine) Water Fee is calculated as follows: \$39 per month = \$468 per year per dwelling unit, non-residential property is \$39 x area / 1500 per month, Sierra County Community Building is \$87 per month = \$1,044 per year.
- (4) Sierra Brooks Water Fee is calculated as follows: \$240.00 per residential equivalent.
- (5) Sierra Valley Groundwater Management District boundaries are the Sierra Valley ridgetops. The affected properties do not necessarily conform to TRA boundaries. The rate is calculated as follows: \$6.00 per parcel of 40 acres or less; \$0.15 per acre for parcels larger than 40 acres.
- (6) Watermaster fees are assessed by the California Dept. of Water Resources for agricultural purposes. They are on specific parcels only.
- (7) No property in Sierra County has a 1911 Act, 1913 Act or Mello-Roos improvement bond.
- (8) Loyalton is the only incorporated city in Sierra County.
- (9) Verdi Zone of Benefit fee is \$331.22 per parcel in 2011-12 and increases by 2% per year compounded.
- (10) These are the 2011-12 Secured Roll tax rates adopted. The 2011-12 Unsecured Roll uses the 2010-11 Secured tax rates because the 2010-11 rates are not adopted at the time the Unsecured Roll is prepared in July.
