Any person appointed to fill the vacancy shall hold the seat until the next regularly scheduled election, November 2025, at which time the 2-year term would be up for election. If the district fails to fill the vacancy or call an election within the 60 days, the Board of Supervisors has an additional 30 days to fill the vacancy. |
