Footnotes:

- (1) All Sierra County TRAs are within the Sierra Plumas Joint Unified School District which includes all elementary and high schools. Part of the SPJUSD is in Plumas County. The SPJUSD has no bonded debt.
 - (2) Solid Waste Fee was changed beginning with the 2022-23 roll and is calculated as follows: \$20.38/loose cubic yard: Example: 1 residence = 18 LCY x 20.38 = \$366.84. Contact 530-289-3283
 - (3) Sierra County Waterworks Dist. 1 (Calpine) Water Fee is calculated as follows: \$71.29 per month = \$923.88 per year per dwelling unit. 530-994-3547
 - (4) Sierra Brooks Water Fee is calculated as follows: \$240.00 per residential equivalent. Sierra Brooks Water Bond \$246.30 As well as a month fee bases on gallons used.
 - (5) Sierra Valley Groundwater Management District boundaries are the Sierra Valley ridgetops. The affected properties do not necessarily conform to TRA boundaries. The rate is calculated as follows: \$6.00 per parcel of 40 acres or less; \$0.30 per acre for parcels larger than 40 acres. 530-289-3283
 - (6) The Emergency Medical Fee (EMS) is a voter approved \$60 fee charged by Downieville Fire Department and Sierra City Fire Department to enhance Medicval Services.
 - (7) No property in Sierra County has a 1911 Act, 1913 Act or Mello-Roos improvement bond.
 - (8) Loyalton is the only incorporated city in Sierra County.
 - (9) Long valley-Verdi Zone of Benefit fee is \$156.52 per parcel. 530-289-3286
 - (10) These are the 2022-23 Secured Roll tax rates. The 2022-23 Unsecured Roll uses the 2021-22 Secured tax rates because the 2022-23 rates are not adopted at the time the Unsecured Roll is prepared in July.
